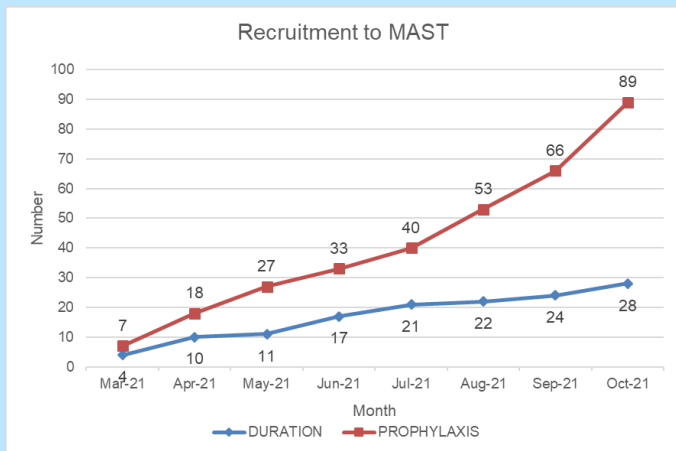


MESSAGE FROM THE CHIEF INVESTIGATOR

FAQs

Q. Who starts tapering for the 3-month participants in MAST-DURATION?

A. The clinician discharging the participant should provide the tapering schedule to the participant and send the letter to their GP for notification.

Q. A mistake was made when randomising a participant on Sealed Envelope. How do we correct it?

A. Please contact the CTC/DM, who will generate a query on Sealed Envelope. This will provide a way of tracking the changes. Once the query has been answered with the required information, the CTC will edit the form. Sites are not able to edit Sealed Envelope for data integrity purposes.
